New digital market place for nature credit markets

- Luontoarvot.fi aims to become Finland's most comprehensive, top-tier marketplace for nature values — with the potential to expand across Europe
- Market place for buyers, sellers and intermediaries
- Will be launched step by step in 2026 (First step in March 2026)
- First of all, a market place for official, authority-confirmed sales
- Later on, also other types of sites/objects for sale (unofficial part)
- In future link to buyers club

Where did it all started from?

- The need for a clear and reliable marketplace for nature positive acts was already identified in 2022
- MTK: Initial concept development and preparatory work were carried out in 2022–2025 (project and and work funded by Sitra on the development of market place)
- **NOW:** Demand for nature credits and other actions has increased → driven by corporate sustainability targets + the reform of the Nature Conservation Act → biodiversity offsetting in legislation, basis for other bd-work as well
- **Objective: a one-stop service that brings supply and demand together**

Where are we now?

Luontoarvot.fi market place was launched in late March 2026

- The first listings have already been submitted to the platform
- This marks the formal launch – the marketplace is now operational
- Sites can now be submitted directly through the service

Who can use the service?

- The marketplace is publicly accessible to buyers and users
- The submission of site listings is restricted to approved intermediaries
 - This governance model supports quality assurance and procedural consistency
- Landowners participate via their designated intermediary

Looking ahead: Key developments planned for 2026

- Introduction of purchase announcements **DONE**
- Expanded expert search functionality **DONE**
- Further development of site profiles and spatial data
- User feedback as a primary driver of development



First experiences and lessons relevant at EU level

- A clear conceptual framework must precede marketplace development and investment
- At the same time, a marketplace should not be over-designed in an evolving system
- User feedback is essential for credible and effective development
- Marketplaces generate valuable market intelligence
- Clear criteria for eligible sites are fundamental for trust and credibility
- Reliability and transparency are prerequisites for market legitimacy
